



# PARTS LIST

Your TRINITY EcoStorage<sup>™</sup> 5-Tier Wire Shelving Rack w/Wheels should include the following parts. Please inspect box contents to ensure you have received all components.

You will need no additional tools for assembly.



#### Please inspect box contents to ensure you have received all components.

Note: The black circular plastic tops in between the shelves are used only for packaging purposes. They are NOT NEEDED. Please discard.

## **ASSEMBLY INSTRUCTIONS**

### **STEP 1: Stationary Option**

Screw each FEET LEVELER (E) into the bottom of each BOTTOM POLE (A). Turn clockwise to screw in place.

## **STEP 1: Mobile Option**

Screw each CASTER (F) into the bottom of each BOTTOM POLE (A). Turn clockwise to screw in place. Make sure the Locking Casters are on the same side.

<u>Use the provided caster wrench to tighten</u> <u>completely.</u> Failure to do as instructed could <u>result in the caster stem breaking.</u>


### **STEP 2: SLIP SLEEVES**

For easiest assembly, do not attach the TOP (B), and BOTTOM (A) POLES until Step 4. Once connected, these will be the posts for the rack.

Each POLE (A+B) has slight horizontal line indentations at 1" intervals. Each SLIP SLEEVE (D) has raised horizontal lines inside designed to lock them in place on the POLE (A+B). On each POLE (A+B), place 1 pair of SLIP SLEEVES (D) at the desired level. Please make sure the arrow faces up and that the word "TOP" is right side up. Do this for each POLE (A+B), and make sure that the heights are identical for each POLE (A+B).

Slide the pair of SLIP SLEEVES (D) until you hear a click to confirm the pair is locked onto the POLE (A+B). DO NOT place more than one pair on each POLE (A+B) at a time.


\* For safety and stability, the lowest SHELF (C) should be lower than the 3<sup>rd</sup> notch from the bottom. \*\* Note: There will be a very small gap in-between the SLIP SLEEVES (D)—this is normal.

### **ASSEMBLY INSTRUCTIONS**

### **STEP 3: INSTALLING BOTTOM SHELF**


Place SHELF (C) on its side and slide the (4) BOTTOM POLES (A) through the holes in the SHELF (C). Make sure that the SHELF (C) corner cylinders are positioned over the SLIP SLEEVES (D).

Stand the unit upright.

\*Note: The level side of the SHELF (C) is the TOP side (the TRINITY logo on the corner cylinders should be right-side up.)

\*\*Use a rubber mallet, if needed, to secure the SHELF (C).

\*\*\*For convenience, place BOTTOM POLES (A) with Locking Casters on the long side of the shelf if the rack will be pushed against a wall OR if the rack is frequently rolled around like a cart place BOTTOM POLES (A) with Locking Casters on the side being pushed or pulled.




### **STEP 4: INSTALLING TOP POLES**

Screw the TOP POLE (B) into the BOTTOM POLE (A).

The tops of the TOP POLES (B) are indicated by the BLACK END CAP.



# **STEP 5: INSTALLING SHELVES**


Repeat Steps 2 and 3, adjusting the height for the desired distance between each SHELF (C).

\*For safety and stability, the highest SHELF (C) should be higher than the third horizontal indentation from the top.

\*\*Use a rubber mallet, if needed, to secure each SHELF (C).





## **1 YEAR LIMITED WARRANTY**

#### TRINITY EcoStorage<sup>™</sup> 5-Tier Wire Shelving Rack w/Wheels Model # TBFZ-0915

Trinity International Industries ("Trinity") warrants to the original consumer purchaser ("Purchaser") of the TRINITY EcoStorage™ 5-Tier Wire Shelving Rack w/Wheels ("Product") that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity's obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User's Manual, or alteration by any one other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product.
